The Order has been passed alleging that the tax was payable by the Company on the gross amount charged by the Local Cable Operator (LCO) from the subscribers and not on the amount charged by the Company from the LCO. The Order was erroneous and the Company filed an Appeal with Commissioner (Appeals), Central Tax and Central Excise, Kochi ("Appellate Authority") on April 15, 2025.</p>	<p>The Appellate Authority, vide its order dated August 21, 2025 (received by the Company on October 29, 2025), has accepted the contention of the Company and has set aside in toto the order dated February 03, 2025 passed by the Joint Commissioner (ADJN), Central Tax and Central Excise, CGST Kochi Commissionerate and quashed the demand of Goods and Service tax, interest and penalty against the Company. The Company, vide its disclosure dated October 30, 2025, has intimated about the order of the Appellate Authority.</p>
